

Chapter 1: Soros in the World

As a financier and a figure with a serious geopolitical influence, George Soros is a radical political and economic liberalist. Despite the fake humanitarian activities presented via public propaganda, he represents himself as an advocate of fundamental human rights.

After receiving philosopher's degree at London School of Economy and Political Science, Soros adopted the internationalist ideas of his teacher Karl Popper. Later, based on Karl Popper's idea of the "Open society" (a propaganda of the person's fundamental freedoms and rights), Soros built his whole system of "proselytism".

Henri Bergson and Karl Popper interpreted the idea of the open society as a possible counterbalancing force against Marxism, Nazism and Communism, which would be based on healthy competition. Here, the most educated and the most conscious succeeds, regardless of religion, race, gender and nation. The main point of this idea, as well as liberalism is the superiority of intelligence over animal instincts, where an individual "is free to choose the life without discriminations and interference".

However, the goals of George Soros are not the least humanitarian and are far from real democracy. There are no moral and spiritual barriers for Soros, his actions seek sole financial benefit, which has resulted the implementation of the risky covered part of this idea.

As a result of the actions of George Soros himself and the organizations and foundations financed by him, financial crises, terroristic acts, revolutions and civil wars were triggered in numerous countries, violence, hate and anti-church ideas were propagated under the cover democracy. He has inculcated suspicion towards the state institutions, and distorted national value systems.

After the graduation from the London School of Economy and Political Science, and a few failed attempts at work, George Soros moves to the U.S., the State of Florida in 1956, to work at the company of his friend, Meyer. Registering his first success there, he starts working at "Arnhold and S. Bleichroeder" company, as a consultant of foreign investments. In this company, George Soros starts the speculations in the stock market.

In 1969 he chairs the *Double Eagle* foundation registered in Curacao, and starts the purchase of securities. The foundation was then inaccessible for the American law enforcement authorities. Up to this day, the activity of the foundation is unknown, however the financial indicators proved that the funds of rich Arabic, European and Latin American investors were “designated”.

As a result of the limitations of broking companies in 1973, Soros leaves the *Double Eagle* and founds his own *Soros Fund Management* foundation. He establishes connections with high-rank American politicians intending to gain insider information, in order to “predict” the fluctuations of securities costs.

In 1973, during the attack by Egypt and Syria against Israel, Soros received secret information, that the amount of the armament provided to Israel by the U.S. is significantly less than the one of the Arabic army. He then buys the securities of “Northrop”, “United Aircraft”, “Grumman” and “Lockheed” companies, producing weapons for the Pentagon. When those companies receive big orders from Pentagon, the prices of the securities increase rapidly.

Soon from the secret report by the U.S. Ministry of Trade, Soros learns that the dependence of the country from the imported coal, petrol and gas is increasing. He then starts buying securities of the companies manufacturing extraction equipment, and receives excessive profit.

In 1979 “Soros Fund Management” is renamed to *Quantum*, and in 1980 it is revealed that the fund had registered a **3365%** increase during the 7 years of activity. On this occasion, Soros has said that the committee on securities didn’t believe that it was possible to work as effectively as him. Thus, they uselessly tried to find reasons to punish him.

Starting from the same year Soros starts using all his influence to interfere into the political processes. He transfers 3 BN USD annually to the *Solidarity* trade union lead by the Polish oppositionist Lech Walensa, but simultaneously establishes good relations with his political opponent General Wojciech Jaruzelski. With the permission of the General Jaruzelski, Soros founds the *Stefan Batory Foundation* in Poland, that operates up to this day.

In the 1980s Soros starts engaging in currency speculations, in fact accumulating capital by not creating or producing securities or values. Besides carrying out transactions based on secret information, he starts triggering currency fluctuations, and as a result-financial crisis at the exchange.

In 1984 Soros returns to Hungary and opens a foundation with the support of the Responsible for the international connections of the Hungarian Socialist Workers' party Ferenc Barth and György Aczél. The foundation was going to finance the development of science. However, Soros just starts taking the talented young people of Hungary to the U.S. and limits the financing of the foundation, which, over time, creates dissatisfaction among the public, even the former scholarship recipients of the foundation, including the future Prime Minister Viktor Orbán.

On September 22, 1985 Soros receives access to the secret data from the New York meeting of the Ministers of Finance of the USA, France, FRG and Great Britain, and he buys Japanese Yen all night. In the morning, when it turns out that there was a decision to reduce the exchange rate of the U.S. Dollar towards the Japanese Yen by 4.3%, Soros gains profit of 40 MM US Dollars.

In 1987 Soros arrives in the USSR for the first time. Here, he assigns the biggest advocate for Western democracy Andrei Sakharov as the Head of his Cultural Initiative Foundation. From 1989, after the death of Andrei Sakharov, Soros closes the "cultural" foundation and continues his activities in the USSR through the *Open Society Foundations*. By the way, up to this day, there has been no explanation on the connection of the creator of the hydrogen bomb with culture.

In 1992 the committee created by Soros eliminated all the personnel of the Albanian University of Tirana, who had opposition views, and who were dangerous for Soros' pro-American President Sali Berisha.

In 1992 the businessman receives secret information from the President of Bundesbank (the Central Bank the Federal Republic of Germany) Helmut Schlesinger and buys 5 BN English Pounds. Then, on September 15, he exchanges the purchased Pounds with German Marks with the exchange rate of 2.82%. When as a result of this

transaction the exchange rate of the British Pound rapidly falls, Soros re-buys the 5 BN with 2548 German Marks. According to the calculations of the experts, he has received a profit of 1-1.5 BN USD from the mentioned transaction alone. That day remained in history as the “black Wednesday” for UK and “white Wednesday” for Soros and the U.S., as the inflation of the Pound by 25% solved several issues for the U.S. as well.

In 1993, when during the process of writing his book, the American journalist Michael Lewis asked Soros about his activities in the Eastern Europe, Soros responded: “Just write that the former Soviet Empire is now called the Soros Empire” [Michael Lewis, *The Speculator*, 1994, The New Republic].

In 1996, two chairs of the Croatian *Open Society Institute* get arrested when crossing the border with 65.000 USD in their hands. During the investigation, it becomes clear that they have paid some of the employees’ salaries and the grants of the politicians with “black cash”. It is obvious, that there was a similar situation in other Balkan countries.

In 1996, Soros triggered a financial crisis in Bulgaria. When the value of Lev in Bulgaria dropped to 2800 Lev for 1 US dollar, Soros exchanged 40 MM USD to Lev. As a result, the value of the Bulgarian currency increased to 1600 Lev for 1 US Dollar, but Soros again re-bought the Dollars.

In 1997 Soros caused a “black Wednesday” in Malaysia, which became the cause of chained financial crisis in a number of South-Eastern Asian countries – Thailand, South Korea and Philippines. This “Asian crisis” had a negative effect on the most vulnerable class of the region, and just within a year, more than 10 million people became jobless. To the accusations of the Prime Minister of Malaysia Mahathir Mohamad, Soros again cynically responded: “If there was ever a man who would fit the stereotype of the Judeo-plutocratic Bolshevik Zionist world conspirator, it is me” [Soros *on Soros: Staying Ahead of the Curve* – George Soros].

At the beginning of the 2000s, during the U.S. financial crisis, Soros was one of the few people, who became richer. Until that, his net worth was estimated to be 11 BN USD, after the crisis, according to *Forbes*, it reached 25 BN USD.

During the whole period of his financial career, using the political acquaintances and the financed organizations, Soros has created a huge agent network all over the world. In the countries where the authorities don't obey, Soros pushes his agenda forward by implementing fake charity and democratic projects through foundations, i.e. puts bombs with long-term perspectives in countries by manipulating the society.

For that purpose, it is effective to apply the social engineering direction of cybernetics, which helps to reveal and use mechanisms of influence on people's behaviors - specific social groups that will control and lead the society. I.e., they create public organizations, movements and initiatives that are engaged in the solution of other problems in the society or the ones of socially vulnerable groups. From the first sight, there is nothing strange, but when other big public issues raise in the country, the given organizations mobilize and involve all their resources in the fight. As a rule, the fight is initially or later on lead by the members and benefactors of the NGOs financed by the Soros' foundation, who, in case of a victory, receive the praise.

With the help of his agent network, Soros is able to make the even disobeying authorities of the countries to pass all the corresponding laws, unacceptable in the given country. For that purpose, the same social engineering is accompanied by the application of the ***Overton window technology***, which is implemented in the following stages:

Stage one: *Freedom of Speech*

The closed topic is thrown into the information field through media platforms and sources, while it still remains closed and unacceptable, however, many people are already informed about that.

Stage two: *Why not?*

The closed and unacceptable topic enters the phase of discussions and is actively covered. Left radical groups are being formed in the society, political activists step out and start organizing summits, explaining the logic of the given phenomenon from a scientific point of view. The phenomenon is given a scientific name, which creates a less negative attitude. People start to question their former beliefs.

Stage three: *That's what we need*

The closed topic has already been opened and become acceptable for the majority of the people have accepted the phenomenon thanks to long-term discussions and coverage. The rumors on “violence” and “provocations” spread, and, as a result, there is a “necessity” to defend: flash-mobs, rallies, leaders of public opinion make announcements condemning “violence”, and the state institutions – law enforcement authorities, court system and the Human Rights Defender are also being involved in the process. The fake scientific justifications of the given phenomenon remain, often based on some historic precedents. And the straight-thinking group of the society is represented as intolerant, illiberal and barbaric.

Stage four: *In a good sense*

The phenomenon is rationalized, becomes somehow acceptable. The problem gains multiple directions, is divided into types. The popular representatives of the society discuss the acceptable, unacceptable and reasonable options. The process of legalizing the unacceptable phenomenon enters the stage of active discussions.

Stage five: *Legitimizing*

Thanks to the Mass Media, publications and discussions, the consciousness of the majority of the people starts to form the belief that the given topic is of primary importance. The tolerance and scientific justification doesn't create suspicions anymore. More independent public figures remain neutral. Publications spread, movies, programs are filmed, and it turns out, that historic precedents are connected to several loved and popular cultural figures. Politicians and businessmen put the topic into circulation and use it for their own benefit. As a result, the formerly radically unacceptable phenomenon is legalized: any opinion against the phenomenon is viewed as intolerance, violation of the freedom of speech and the human rights.

State capture

The fake thesis of *state capture* holds a special place in the activity of Soros' agent network. Sorosists can be easily recognized by this phrase. This is the phrase that depreciates all the state achievements, artificially exaggerates the real problems of the country, and raises informational noise. As a result, the active part of the society gets involved in civil disobedience and protests, instead of developing and installing effective mechanisms of solving the problems.

Soros is led by a long-term strategy: the seeds he plants become fruitful years later. As the state is inert and mainly fights against the problems that occur at the given moment, there comes a time, when it is too late to do anything. That is the time when Soros collects the fruits of his seeds: the society is convinced that the only solution is the revolution.

In case Soros' activity in the given country ends with a revolution, the new authorities are obliged to give a legal-political estimation of the former ones, confirming the fake thesis of the *state capture*. This is necessary to terminate all the laws, state and legal documents and international agreements not corresponding to George Soros' agenda.

Around 32 attempts of colored revolutions organized by the efforts of Sorosists following the above-mentioned principle were registered in the world. All this political disobedience has one general specific feature – everything starts as a peaceful movement, accompanied by provocations of Soros activists, which causes bloody events in some of the countries.

From this point of view, the *Bulldozer Revolution* in Serbia, that took place in 2000-2001, and the *Revolution of Roses* that took place in Georgia from 2003-2004 are worth mentioning. Both of the revolutions were carried out following the same method, and both cases the leaders and later the state leaders were Soros' grant recipients. Like the *Otpor!* youth movement in Serbia, *Kmara* in Georgia was also sponsored by Soros. It is worth mentioning that until implementing the revolution in Georgia, members of *Kmara* movement were visiting Belgrade, led by the future president Mikheil Saakashvili to take

part in the “lectures” of *Otpor!*. The financial sponsorship of those trips by Soros' foundation has been confirmed with corresponding documents.

However, as we have already mentioned, the revolutions carried out by Soros are often lead with blood and victims. We can note the most bloody and sensational revolutions of the recent years:

- The revolution in Kyrgyzstan of 2010, during which 84 people died and around 1500 were injured,
- The *Bread Revolution* in Tunisia from 2010-2011, during which, according to UN data, 219 people died and 510 were injured,
- The *Revolution of Lotus*, one of the revolutions of the *Arabic spring* that took place in Egypt in 2011. As a result of the clashes during the revolution, the number of victims, according to UN data has reached 300, and according to the new authorities – it comprises 846,
- The *Revolution of Dignity* that took place in Ukraine in 2013. This revolution is more popular under the name *Euromaidan*, during which 150 people were killed and 1127 were injured. The civil war that started as a result of the revolution took lives of 13000 people, and around 25 000 were injured. The country also suffered territorial loss.

As a result of the attempts of colored revolutions, it is possible to see such scenarios, as bloody clashes, change of regime, civil wars, territorial loss, economic downturn, prosperity of the oligarchy, corruption and, at last, loss of statehood. And usually, one or two of the above-mentioned events take place in a country as a result of that attempt. The revolution in Ukraine is specific, as during that revolution, Soros' all technologies were applied, and almost all the above-mentioned events happened.

However, not all the countries give in to Soros without a fight. During the recent years anti-globalist tendencies develop all around the world. They usually turn into movements against the activities of Soros. Some of those movements have already registered success by limiting or blocking the operation of Soros' foundation.

The *Open Society Foundations* was operating in the USSR at the moment of its collapse: later, it expanded the frames of activity.

In the post-soviet Russia, Soros was supporting the representatives of opposition, who had liberal views. In 1999 the Soros' foundation was financing the Russian United Democratic Party, participating in the Parliament elections. The party was founded by Grigori Yavlinski. Yegor Gaidar, Boris Nemtsov, Anatoly Chubais and others were also supported by Soros.

In 2015 the *Open Society Foundations* of Soros was included in the list of the unwanted organizations by the Prosecutor General Attorney of the Russian Federation. This happened because of the active educational, cultural, scientific, public and political neoliberal and pro-American propaganda that was implemented for years. According to the RF law enforcement authorities and sociological experts, the activities of the foundation and the benefactors were a threat to national security. The thing is, soroists in Russia were supporting the Chechen separatists, and there is a theory, that George Soros has provided 10 MM USD to the *All-National Congress of the Chechen People* lead by Akhmed Zakayev.

Today, although the activity of the *Open Society Foundations* is terminated in Russia, several organizations, indirectly sponsored by it, continue operating.

It is notable, that Soros' historical homeland – Israel, his residence - the U.S. and his birthplace - Hungary, has also understood the danger of his state-destructing activity.

Based on his own investigations Israeli journalist Itai Reuveni claims that Soros finances organizations and unions that can harm Israel. According to the report presented by *NGO Monitor* in 2013, Soros has interfered in the Arabic-Israeli conflict, and according to the report of 2016, he is financing the *Palestinian People's Liberation Front* terrorist group. We are talking about a very serious sum: during the last hours of operation, Obama's administration hurriedly transferred 221 MM USD to Palestine. Congress learned about that only the next morning, on the day of President Trump's inauguration. Moreover, the fact that the U.S. Democratic party receives huge funds and other support from Soros, is not a secret.

It is not a coincidence, that the Ministry of Foreign Affairs of Israel made an announcement about Soros, who continuously undermines Israel's democratically elected governments by funding organizations that defame the Jewish state and seek to deny it the

right to defend itself. The antipathy towards Soros in Israel is the response to his regular hostile attitude towards the Jewish country. He is not just criticizing the policy of this or that Government, but actively finances organizations that question the right of Israel to exist. Moreover, Soros is actively interfering in Israel's pre-election campaigns, trying to bring left liberals to rule. The above-mentioned would remain as the problem between just Soros and Israel, if his anti-Israeli attitude didn't affect the U.S. Department of State. Everyone in Israel is well aware and has known for a long time. It's not a coincidence that the relations with Washington here started turning upside down during the administration of democrats, financed by Soros. People are talking about the closeness of Soros and the U.S. high-rank democrat officials, and those are not just conversations within Israel.

Wayne Madsen, the author of journalist investigations and the book *Soros: Quantum of Destruction* has his own view on the activity of Soros in the Middle East: "We see Soros as a financier, who stands behind the so-called thematic revolutions".

The anti-Soros fight in Hungary has started and was led by the country's Prime Minister Viktor Orbán, who was one of Soros' grant recipients, who studied at the Oxford University in 1989. The demand of the Hungarians was to close all the facilities founded by Soros in the country, and in particular, the Central European University chaired by Soros' elder son Robert Daniel Soros. The main reason for the dissatisfaction was the huge flow of immigrants from the Middle East and the Soros' agenda of providing them with shelters.

Soros offers Europe to accept at least 300 thousand immigrants annually and spend 30 BN Euros on the provision of shelters. The businessman is confident that a higher quota will give the immigrants an opportunity to enter the EU in an entirely legal manner. Europe is offered to gradually drown in the increasing flow of immigrants but now, this would be done not in a panic, but in the framework of the system of *Open Society Foundations*.

With the huge flow of immigrants, Europe started immersing in the lawlessness and bloody terrorist attacks carried out by Islamic radicals. And as there are many facts proving their indirect funding by Soros, the compulsion of the agenda on providing the immigrants with shelter filled the glass of patience of the authorities and civil society of several European countries, and the anti-Soros wave had a chain reaction.

Currently, Italy, Poland, Macedonia and other countries are fighting against Soros' activity.

American political commentator Phil Kent notes: "Soros likes the idea of uniting nations. He likes to rule the world. Soros is not for the multi-national country, similar to the U.S., Russia or EU. Opposite. He tries to destroy everything national. The tools of his influence are the open foundations, organizations, public institutions, that are numerous. He is almost inside every state government system, and he is trying to destroy the national state institutions.

In his book "Soros and the open society: meta politics of globalism", French journalist, political commentator Pierre-Antoine Plaquevent notes that with the implementation of the idea of the open society, Soros seeks exclusive power – to rule the humanity in one general power model by merging and destroying national and ethnic identities, customs and the peoples' history. («**Gouvernance Mondiale**» - **World governance**)

Chapter 2: Soros in Armenia

George Soros' "Open Society Institute" (later – "Open Society Foundations Armenia") was founded in Armenia in 1997.

From 1999 Garegin Chugaszyan became the Chairman of the Board of the Armenian office of the *Open Society Foundations* (OSF). Chugaszyan was also the member of the facility's Information sub council (Budapest, Hungary) and took part in the decision-making process of the information and connection projects implemented in around 30 countries of the OSF.

They have consistently built their fake propaganda of democracy by financing projects of the educational and humanitarian spheres (protection of women's rights, problems in the army, anti-corruption fight and environmental issues).

As it turned out in the future, the fake propaganda and spread misinformation carried out in the anti-corruption and environmental spheres, were the most effective ones.

In Armenia, the hooligan groups are at the bottom of Soros' agent network. They are basically amoral people with a distorted value system, people with a dark past, who carry out all the "black job" of Soros' network and get paid for it.

1. Virtual hooligans: Generally manage fake user accounts, creating an imitation of public opinion beneficial for them by posting comments in the social media or under other actively discussed publications. This helps them lure the neutral or less informed part of the society. In parallel, they recruit real users who have been under the influence of Soros' agent network propaganda for years. Then, they organize attacks against dissidents in the virtual platform with already formed groups: they curse, put labels, insinuate and call names, aiming at silencing the people with opposite views and solving their own problems.

2. Street hooligan groups: People of young age, recruited by Sorosists generally through funding student, educational projects and grants. As a result of filtering, persons who implement aggressive provocations against dissidents (otherwise-minded) (repressions using force, attacks, attempts of kidnapping (find the video of the attack against Narek Malyan, leader of "VETO" social-political movement here <https://www.youtube.com/watch?v=XqcjHYNKI3g>))

3. Human rights activists: The next "layer" are the so called human rights activists. These are a group of people who have announced themselves as human rights defenders, feed from the office of Soros, and implement group attacks on this or that state institution by the orders of the mentioned Office, disguised by various conventions ratified by the state and distorting the reality. As a result of their activities, criminals feel protected. Simple citizens become undefended, as the Sorosist human rights activists' aim is to find flaws in the activity of state authorities, and if there are no such flaws, they make them up.

For many years, "human rights defenders" have supported the propaganda against law enforcement facilities, in particular – police, where the main tool applied is the demand to show tolerance towards the citizens, hidden under the covers of the protection of human rights. In case of any lawful response to the violations by the police, the offender's rights are being addressed, and the offender is presented as a victim. The crime they have committed is moved aside, and very often the disrespectful behavior towards the policemen, which is also criminally punishable, is also ignored.

These “human rights defenders” are also responsible for justifying and glorifying the offenders and criminals hidden under the covers of fake democracy and human rights protection, beneficial to them. It is worth mentioning, that the worse the crime, the heavier the crime, the more effort they put in protecting the criminal’s rights. In such cases, the protection is carried out following a specific scheme.

Fake news are thrown into the information sphere through the media outlets sponsored by Soros’ office. That news quickly spread in the social networks by the fake accounts and recruited users with large audience. As a rule, there are many popular cultural, social and political figures and other representatives of public opinion among those gathered people. To reach their goals they use the already mentioned Overton Window technique. For example, in August 2017, a drug addict who had been formerly convicted, had taken a girl hostage and was threatening to cut her neck with a knife. After long negotiations when the criminal was already going to realize the threat, the police had to shoot him in the shoulder. The criminal died from that injury and sorosist human rights defenders raised an information noise with fake news and false claims, telling the police officers injured the criminal on purpose, entered the building and shot him for the second time, as he was a person with a difficult childhood. A criminal case was initiated, and just a few days later it turned out that all the claims and announcements were a lie.

There are many similar examples, when sorosist human rights defenders create mistrust towards state institutions.

Another example of the activities of fake human rights defenders is the murder case of Yerevan State Medical University student Iosif Aghajanov by the psychopath murderer Mher Yenokyan, who ruthlessly killed the young man and demanded ransom for the dead body. The propaganda was carried out the following way: first, all the negative comments and information regarding the murderer was consistently removed from the media. Moreover, the video of the discovery of the body and the murderer’s confession was deleted from all the internet resources with the active efforts of sorosists, who claimed there was copyright infringement. The next step was publishing news that presented the murderer solely under positive light: a woman who had received a grant from Soros’ foundation and declared herself a human rights defender, was spreading that news.

In parallel to all of this, Sorosists were consistently spreading fake, false and discrediting news about the murdered young man's relatives and family, trying to make represent them as negative character, which caused great suffering to those people for years.

All the above-mentioned was disclosed in the framework of "VETO" movement operation, and the society understood that this is again one of the fabrications and manipulations of Soros' network. Moreover, Sorosists who had received grants for this work, had filed applications for the early release of the cruel murderer. Luckily, the application was rejected after the fuss raised by "VETO".

All of the above-mentioned help us conclude that the criminals are under the protection of Soros' network.

Similar cases have been used by Sorosists for years to demoralize the society, create fake values and plant and deepen mistrust towards the court authorities. In addition, the usage of double standards is becoming a pattern, i.e. there is a preconceived attitude towards the criminals under the protection of Sorosists, making them look innocent, and the lawsuits filed against them are fabricated. In case people with different beliefs are suspected in any behavior condemned by the society, there is not even the presumption of innocence.

4. Provocative groups: Sorosists also have groups of people who provoke the police officers, who maintain order during public events. The whole process is filmed with several cameras simultaneously, but only the mounted parts where police officers argue with the Protestants, are published in the social media. The parts where the protestant provokes and even curses the policeman, is always removed from the videos, as the people who insinuate and film such situations are the same Sorosists, who stage, film and mount the footage upon their own discretion and publish in the social media, aiming at deepening the mistrust against the law enforcement system.

With the efforts of Sorosists, insults and slander were decriminalized in RA, which gave complete freedom to provocateurs to show degrading attitude towards law enforcement authorities in public areas. This attitude continued planting mistrust and hate towards the police.

5. Army: Army is also a target for Sorosists in the countries all over the world. To reach their goal, they pay special attention at the “protection” of the soldiers’ rights, to speculate it in the future. By exaggerating any little problematic thing, they present it as a ubiquitous problem, as if the solution requires systematic changes.

Officer squad is regularly targeted. Sorosists have specific hate towards high-rank military officers. The army elite is constantly accused of robbing the army, keeping the soldiers hungry and naked, abusing them psychologically and physically, making them commit suicides, and other horrible crimes. The majority of these accusations, of course, is not confirmed, however, it is not significant, as spreading fake news for years gives results. As the society is very sensitive towards the army, and bad news spread very fast, people don’t even try to clarify whether the information is fabricated or not. Thus, myths are quickly created around the army, and the further activities of Sorosists is built on those myths.

6. Sponsoring terrorist groups: In July 2016, the armed *Sasna Tsrer* terrorist group stormed the police station, that held a big amount of armaments and weapons. The terrorists presented political demands, including freeing their jailed leader. The storm of the police station resulted in the murder of three policemen, hostage of doctors, destruction of state property, robbery of the ATM machine on the territory of the police station and terror of all the residents living nearby.

To force the demands of the terrorists to the State Government, the whole agent network of Soros in Armenia started the propaganda of the terrorists' justification and glorification, to bring the people to the streets and trigger new bloody clashes. The propaganda of Soros media and human rights defenders was based on the same fake news published in the information sphere during the active military actions in April, the majority of which was already denied. To justify and glorify the terrorists, Sorosists had created 1000 fake user accounts in advance, with which, as in the case of the propaganda for the benefit of murderer Mher Yenokyan, they organized virtual attacks against the adequate users who were condemning the actions of the terrorists and mourning the deaths of the police officers. The law enforcement system, in particular, police and army were the main target. Mounted footage regarding the actions of the police officers was published, and various fake news were spread regarding the conditions of the police

officers' deaths. Everything was accompanied by the same insults, in particular, against the family members of the killed police officers.

Interestingly, the members of the terrorist group were gathered and coordinated by Garegin Chugaszyan, President of the Board of the Open Society Institute (OSI) office in Armenia from 1999-2001 who was out of sight after the storm of the police station, and did not appear until 2018.

It is also worth mentioning that funding of terrorist groups in the court was carried out by two organizations – Europe in Law and The Helsinki Association of Human Rights, sponsored by Soros.

7. Religion, church, education: Sorosists also target religion in the face of Armenian apostolic church, which is one of the guarantors of preserving national values in our country. The church has an important historic value in our country, and is respected by even the non-religious part of the society, and the RA Constitution confirms that exclusive role.

Alongside all of the above-mentioned, an ideological and systematic campaign was being carried out against the church. One of the outstanding Sorosists who is a deputy of the currently ruling party, and was formerly a Deputy Minister of Education and Science, has published a book funded by Soros' office, regarding the content changes of the teaching process of *History of Armenian Church* subject at schools. According to the book, the principles of teaching the subject should be completely reviewed, as it shows discrimination towards the people with different religious beliefs. This, however, is far from reality.

After the change of the governing power, the officials who have “conquered” the Ministry of Education and Science started moving this thesis forward. According to Deputy Minister Arevik Anapiosyan, who is a Sorosist, the ministry is keen on removing the subject *History of the Armenian Church* and teaching it as an integrated subject.

The next sphere that has strategic significance is **education**, which is also not free from the interference of Sorosists. The latter are for non-formal education. The reason is their aspiration for radical freedom: they are against any manifestation of coordination and discipline, including in educational institutions. The Soros elite has been supporting the

foundation of alternative educational facilities in Armenia for years, as their children, as a rule, study in such facilities, free from the discipline and methods of a primary school. Sorosists target not only the schools, but also the higher education institutions.

In the higher education institutions, Sorosists finance various educational programs, and manage to lure the students who are inclined to cooperate with them with the perspective of education abroad. Those students leave for foreign countries and very often don't return back. Those who come back, have already changed value system, Soros' agenda and ideology, which is the result of the influence of Soros community. In fact, this process of brain drain and decay of state education system, that raised a wave of protests in Hungary in 1980s, has been taking place in Armenia for years. By the way, the education system is not free of the "anti-corruption fight", which has helped the Sorosists to fire the best specialists of the sphere and replace them with anti-national and anti-state employees.

8. Sorosists in the Government: change of power

As a result of nearly 22 years of work, Sorosists managed to persuade the society that the Government is responsible for all their failures, that they have been robbed, that their freedom of speech was repressed, abused and that the "state *was captured*". As a result, there was a change of power in April 2018, with the active participation of Sorosists.

By speculating their big investment in this change, Sorosists received government levers and are now imposing their agenda to the Republic of Armenia from already ruling positions.

Today the Sorosists have their share in the executive and legislative authorities, their own ministers, heads of law enforcement and legal authorities. Today, the ministers of education, science, culture and sport, health, justice, labor and social affairs, 30 of the 130 deputies of the National Assembly, the Secretary of the National Security Council and the head of the Special Investigation Service, whose brother, by the way, is Chairman of the Board of Directors of the Soros Armenian office. In all of these facilities, there are also Sorosist deputy ministers and administrative staff, and the part of the Sorosists who did not get involved in the governance of the country declared itself a civil society.

Over the years, a part of the hundreds of organizations opened in Armenia through direct and indirect sponsorship of the foundation have merged with the most active and successful ones. There are now dozens of Sorosist media outlets in our country, about 30 of which are actively operating, and over 100 Soros NGOs and movements, around 70 of which are the most active ones. All of these media outlets and organizations are interconnected and, when instructed, resources are pooled and easily moved from one sphere of activity to another. For example, representatives of non-governmental organizations involved in the protection of sexual minorities, disabled people, women, and children in Armenia, as well as *Sasna Tsrer* terrorist group with their supporters today are the pioneers of the environmental front.

By the very first decision signed by the newly elected Prime Minister after the change of power, the Catholicos was deprived of state protection, which was unprecedented in the sense that even during the atheist Soviet rule the leader of the **Church** had always been protected by the state. This decision was followed by both informational and physical attacks by the Soros agency network against the national Church. Demanding the resignation of the Catholicos, the Sorosists kept the Holy See besieged for several days, littering the surrounding area. All this was accompanied by active anti-church propaganda by virtual hooligan groups in the social networks. The attacks against the Church did not end there. The street hooligan group, which also included supporters of *Sasna Tsrer* terrorist group, closed the way of the Catholicos's car outside the Church. And when the Catholicos tried to walk on foot, the offenders attacked and began to push him.

This hooligan group did not take any responsibility, moreover, the leaders were encouraged by the Government: the most active of them was assigned as the President of Armenian State Economic University Gyumri branch. Sorosist preachers also demand to make the tax legislation stricter towards the Armenian Apostolic Church, though according to the Constitution, the church and the state are separated and the state doesn't have a right to interfere in the internal issues of the church.

Shortly after the change of power, under the pressure of Sorosists, the Government of the country also changed the restraining order and released the members **of the group that had implemented the terrorist attack** in July 2016.

Receiving freedom, the terrorists try to engage in politics, and have created two political forces – the *All-Armenian Party Sasna Tsrer*, bearing the name of the terrorist group, which was formed from the members the terrorist attack and those who have blood ties with them, their supporters and mainly the *Citizen's Choice* party consisting of sorosists who obviously protects the terrorists. Covered under the propaganda of fake patriotism and nationalism of *Sasna Tsrer* party, sorosists recruit the conservative members of the society, while the *Citizen's Choice* party gathers people with liberal views, thus keeping the representatives of opposing ideologies under their influence.

Along with all the above-mentioned, there are several operations carried out in the sphere of **education**. The class times of subjects dedicated to the preservation of national identity have been reduced, a draft law was developed towards making the subjects of Armenian language, Armenian literature and Armenian history not compulsory at the universities.

All those processes are accompanied by obvious and covered violations of law, which are not adequately addressed by the law enforcement system. Many actions including violations of law are left ignored and a corresponding procedure is not carried out. Police system has also become weak and demoralized. The atmosphere of anarchy and impunity has reached a level where there is an unprecedented increase of crime, and even the lives of the police officers are in danger. The attacks against police officers and police stations have become more frequent (there have even been cases of death of police officers during such attacks). This is a phenomenon in our country, and Armenia, which was considered as one of the safest countries in the world as of 2017, has had a significant degradation from the point of view of safety.

9. Validation of Istanbul convention: During the recent years, the society in Armenia was starting to grow, treat the healthcare problems with responsibility, treat the vulnerable groups with care rather than compulsory tolerance and accept them as full members of the society. However, during the period preceding the revolution, sorosists started raising intolerance and irresponsibility among the society with their propaganda. After the revolution, the propaganda reached its peak.

An aggressive vaccination campaign started in the **sphere of healthcare**. There were discussions on passing draft laws on mandatory vaccination with vaccines that hasn't

passed the trial required for the use by the people. E.g. the vaccination with “Gardasil”, an outdated and non-applied type of a drug, for underage girls. To heat up this topic, Sorosist preachers were leading an information fight also towards the simple people who were speaking against vaccination in Russia.

It is worth mentioning that Soros often funds groups that have opposite points of view. E.g. he funds both the campaign against selective **abortions**, and the campaign on the protection of “abortion as women’s fundamental right”. By the way, during those campaigns suspicious indicators of selective abortions were published, as in many countries, including Armenia, it is legally allowed to do an abortion only within the period, when the gender of the child cannot be determined. If there is a selective abortion, the data is not registered, as it is illegal. When publishing data, Sorosists do not mention the information source. Therefore, the indicators cannot be reliable.

After the change of power, representatives of the LGBT community started provoking intolerance and attacks. E.g. in August 2018, a group of LGBT people appeared in one of the most conservative villages of Armenia. There, they triggered a clash with local villagers by violating the public order, disturbing the neighbors, and showing improper behavior in the presence of underage children: as a result, the villagers received criminal prosecution. There was a big informational fuss, of course, organized by Sorosist media outlets and preachers. The conscious part of the society, which, of course, had understood the provocation, started being labeled as homophobes and radical intolerants. Various groups of transvestite prostitutes started regularly triggering fights and brawls in the streets and spreading their allegedly beaten faces in the social media. Moreover, a group of 30 transvestite prostitutes, armed with bats, entered a police station in the center of the city and beat the staff on duty: several police officers were hospitalized after this attack. However, no one was punished. The harassment of transvestite prostitutes against the police officers regularly reoccur in the form of attacks on the streets, and the video footage appears on the social media.

In November 2018, another transvestite prostitute appeared in the center of public attention. The latter had published a photo with the Sorosist Minister of Education and Science in his office and written that he was satisfied by the meeting with the Minister.

According to the rumors, the meeting of the transvestite prostitute and Minister of Education and Science had been about expanding the rights of transvestites at schools. However, in spite of the official requests of various media outlets regarding the above-mentioned discussion, the ministry did not give any clarifications.

The last strike of this campaign was the speech of the transgender prostitute at the National Assembly during the sitting of the standing Committee on Protection of Human Rights and Public Affairs, while there was a real wave of intolerance in the society. When the public raised justified protests, the Sorosist deputies, the ones against him, Government and opposition deputies started putting the responsibility for the appearance of the transgender prostitute in the National Assembly on one another. Up to this day, the political force initiating the appearance of the transgender prostitute in the Parliament is unknown, and it is not clear why the current Government is showing an unhealthy love towards transvestite and transgender prostitutes.

The intellectual liberal youth of the country played the biggest role in this campaign, which is an interesting subject for research.

They are not Sorosist human rights defenders, they are leaders of public opinion, who do not have a direct connection to the *Open Society Foundations* but openly preach the acceptance of laws in Soros' agenda. In general, they are ideological people, real radical liberals, and the most interesting thing is, they are friends both in virtual and in real life.

One of the legal initiatives of Soros' agenda precedes the transfer of several topics with a close connection to the law into the information sphere. Following the technology of Overton's window, they start opening the topics by making small allusions in the form of humorist posts and memes published in the social media. From a certain stage, they start showing open interest towards the topic and spread the news they know, inform their followers and organize discussions. This process can last for years. From the first sight, the analyses and comments of these persons regarding the given topic may seem adequate and reasonable. Months before the passing of any law in Soros' agenda, this group starts its propaganda.

For years, they have been holding an interesting campaign on different topics – LGBT, vaccinations, light drugs, feminism, abortions, porn industry, and statistics of domestic and sexual violence in the world. At first, the components of propaganda were invisible in their activities. The propaganda became apparent, when the topic got included in the agenda.

In June, 2019 several articles appeared in the Armenian media about a girl who had been raped. The case had occurred in 2018, the noise had risen and faded, the rapist was sentenced to jail, and a year later they brought up a big fuss on the topic again. This time, one of the members of the above-mentioned group started publishing letters on their Facebook page, allegedly written by victims of violence. With a strange operability, the publication of letters became a flash mob with the hashtag “the voice of violence” that filled up the media platform for several days with the active efforts of Soros media outlets. In parallel, the remaining members of the group started discussing and preaching the validation of the convention on “Preventing and combating violence against women and domestic violence” (Istanbul convention). “VETO” social-political movement informed the society that the flash mob is just the preparation stage for the validation of Istanbul convention, which was regularly denied by that group. However, months later, when it was already impossible to hide the truth, they were obliged to accept that. It turned out, that more than 200 letters of rape were not real. This was followed by the official announcement of the police declaring the impossibility of opening a criminal case with any of the mentioned letters, as they were not real, and none of them contained actual circumstances. Even the person publishing those letters announced they didn’t know anything about the Istanbul convention; the remaining sorosists started presenting violence and rape as a national and cultural peculiarity. Moreover, the person publishing the anonymous letters, who allegedly didn’t know about the Istanbul convention organized a discussion on that topic and became a speaker. All of the above-mentioned created an impression that every single Armenian man has raped or beaten a woman or a homosexual man at least once in their life, and all the women are suffering from violence every day including sexual abuse, which of course, is not true.

After the story with the letters, Istanbul convention became the main topic of discussion for the public. Lawyers started informing the society about the fact that several provisions of the convention contradict to our Constitution, and the sorosist Minister of

Justice and Sorosist law enforcement authorities opposed mentioning that this is just a matter of interpretation.

Seeing that it is impossible to persuade the society about the necessity of validating the Istanbul convention with just propaganda, Sorosists started systematically storming the Constitutional Court, the authority making the final decision.

By the way, Istanbul convention is George Soros' global project, where he draws several countries.

10. Judicial system. Altogether, in the post-revolutionary Armenia a new open campaign has started against the country's judicial system. From the very next day of the revolution Sorosists started demanding the implementation of transitional justice and application of vetting against all the judges. For that purpose, Ruben Karanza, an expert of ICTJ organization funded by Soros, was invited to Armenia. On June 7, 2019, the Minister of Justice resigned upon the demand of the OSF Executive Director, as the minister was slowing down the implementation of transitional justice and vetting. On June 19, the OSF Executive Director assigned her preferred candidate Rustam Badasyan as the Minister of Justice. On the following day, harassment started against the supreme judicial authority of Armenia – RA Constitutional Court. In his inauguration speech, the Judge of the CC, forced to the state authorities by the Sorosists, declared himself as the President of the CC. This was followed by the attacks on the acting president, justifying that the latter should resign, as he is not legitimate.

Members of *Sasna Tsrer* terrorist group started protests in front of the Constitutional Court. Only thanks to the two-day campaign and promise of a permanent sit-in organized by "VETO" movement in protection of the CC, Sorosists temporarily left the Constitutional Court. However, in October, one of street hooligan groups attacked the office of the media outlet managed by the sister of the President of the CC, because of the disagreement regarding one of the articles published by the media outlet and announced that the president of the CC and his sister should be expelled from Armenia. The close people of the president of the CC were arrested without any legal justification, former officials were arrested and accused of seizing power, the children and elderly father of the president of the CC were called for interrogation. The campaign against the constitutional

court, and in particular, its president, crossed all the possible legal and moral limits, which was unprecedented in our country.

It is worth mentioning, that all the criminal cases against the former officials, judges and generals were investigated by the Special Investigation Service, chaired by the brother of the President Board of Directors of Soros' Armenian office.

11. State capture and anti-Russian propaganda. Using all their resources, including government connections, "civil society", opposition and media outlets, sorosists have started a new active stage of activity to bring forward the thesis of *State Capture* demanding the new Government to give a legal-political assessment to the previous one. As the Russian Federation, an enemy targeted by George Soros, is the strategic ally of Armenia, with whom our country has 250 inter-state, inter-governmental and inter-departmental agreements and contracts, are joint members of Collective Security Treaty Organization (CSTO) and Eurasian Economic Union (EEU), sorosists lead an active and fierce anti-Russian propaganda in Armenia. If the Government accepts that the state has been captured, with the next logical step, it will be forced to terminate the most important agreements and contracts between Armenia and Russia both in the military and economic spheres.

That propaganda is dangerous for the security of our country, however, the new authorities at least "don't notice" the tricks and activities of sorosists' propaganda. E.g. in October 2019, during the meeting of EEU in Armenia, the journalist of Georgian sorosist "Rustavi 2" media outlet appeared in the meeting location, with the interference of RA Prime Minister. He directed not decent questions to the RF president, sorosists implemented an anti-Russian campaign in the EEU meeting location, while "VETO" movement not only wasn't allowed to approach the location of the meeting closer than 2 km and implement a campaign informing about the dangers of Soros, but also was surrounded by numerous police officers in a square quite far from the meeting location.

In spite of the allegedly increasing economic indicators, published by the new authorities, there is an economic downturn in the country – GDP is dropping, foreign investments have reduced by 11 times, unemployment is increasing. Thus situation is a consequence of the geopolitical deadlock occurred as a result of the problems triggered by the sorosists. The conscious part of the society realized that the national image, traditional

values and the existence of the state itself are in danger. As a result of all the above-mentioned facts, there was a counter-effect – various individuals, unions, organizations and movements started voicing their disagreement.

Chapter 3: the fight of “VETO” social-political movement

In the past, Sorosists voiced the opposition, and people, having preconceived attitude towards the word of the ruling authorities, didn't go deep into the character and purpose of Sorosists' activity. The society was viewing them as brave people who raised serious questions i.e. the word of Sorosists from opposition was endowed with some kind certainty.

After the 2018 April Revolution, character of the activity of Sorosists changed completely. Now they are speaking from the Government positions. After conquering the state resources, the opposing human rights protection system of Sorosists collapsed. Sorosist human rights defenders or civil society or were to criticize the pressures and prosecutions implemented by the new authorities, or consent them with their silence and agreement. As they could not criticize the omissions and flaws of their own Government, they chose the second option and received their share in the Government - their own ministers, deputies and heads of legal authorities.

After getting their hands on state resources, Sorosists started representing a bigger danger and the question of a counter-force became fatal.

The conscious part of the society started understanding that the activity of Sorosists from state positions is becoming an issue of national security – the national image, national values and the existence of the state overall is in danger. In fact, Sorosists were already capturing the state with their own agenda.

The fight against Soros' network in Armenia was being carried out by different individuals – political technologists, social psychologists, economists, media experts and other specialists separately, each with their own methods. Within some time, after assessing the danger of the whole Soros agent network from their points of view, each of those specialists understood that there is a need of systematic response to that destructive

activities. It was decided to combine the forces and resources and develop a joint strategy and methodology of the fight against Soros' network.

Thus, **"VETO" social-political movement** was founded, which started applying the following three-stage technology in its anti-Soros activities:

1. Raise of awareness

Soros' agent network in Armenia has kept the main media resources under their influence for years. With their help, it has consistently carried out its own propaganda and kept the real purpose of Soros and his network hidden from the society.

With the first step, **"VETO"** crushed the informational blockade. Materials, hidden from the public for years, started being published. They referred to George Soros' ideology, his activity all around the world, and the destructive consequences. **"VETO"** started raising awareness among the members of the society. To this end, the movement started translating and spreading literature, duplicating films regarding Soros and the activity of his network, opened a Facebook page, launched a website, containing information on several languages.

2. Boomerang fight: Using Soros' methods against Soros

"VETO" started applying the technologies of Sorosists against Soros' network as it turned out that this is the most effective in the fight against the authorities. It would be harder to fight against Sorosists when they were a part of the opposition, as they were presenting themselves as persecuted fighters. As practice showed, Sorosists are powerless against their own methods, and do not have countermeasures.

3. Lustration

The people, unknown by the public, are an important and crucial part of Soros' agent network, and the public figures are the human rights defenders and various activists,

who comprise the visible exterior part of the network – the first line. The persons making decisions regarding grant funding and implementing them are people hidden from the society. In this strategic stage “VETO” applied the technology of lustration, which re-addressed the negative attitude formed in the public against Soros’ agent network to the guilty people – the staff of Soros’ headquarters, who were in a comfortable obscurity zone. It is worth mentioning, that from the very beginning of lustration stage the management of Soros’ Armenian office closed the names of grant recipients on the foundation’s website to avoid further inconvenience. However, this was also unhelpful.

As a result of the consistent implementation of the above-mentioned three points, “VETO” movement registered positive dynamics of indicators within only three months of activity.

Beneficiaries of Soros’ office, including the sorosist state officials, switched from an accusing tone to a calmer, justifying tone. The rating of sorosists dropped so much during those three months, that they violated the criminal code and organized an attack on the leader of “VETO” movement, by panicking and forgetting the democracy and freedom of speech they propagated. After the attack, they announced that they are sorosists and they aimed at silencing the founder of “VETO”. Understanding that it is impossible to silence “VETO” by force, they tried to suppress the leader of the movement with criminal prosecution. This method was also ineffective as “VETO” operates solely within the frames of the law.

With the next step, they started discussions at the National Assembly regarding the draft law on limiting the freedom of speech through the sorosist members of Parliament.

Today sorosists have went out of their comfort zone in RA and appeared in so said uncomfortable situation. For years, by spending millions of dollars, they have reached the change of power, and then, “VETO” movement appears and terminates their success. From a certain moment, the sorosists, used to acting secretly, had a problem of leaving their homes without being unnoticed by the society. Their operation started receiving hate from the public. Currently, instead of implementing their own agenda, sorosists are obliged

to follow a new one – defend from “*VETO*”, by using their government connections and denying their previously propagated values.

However, the Sorosist human rights defenders in Armenia are deprived of the public trust and support, their activists have been marginalized, and hooligan groups - discovered. In fact, no one believes their fake propaganda of humanity and democracy anymore.

Chapter 4. The offer of “*VETO*” social-political movement

So, within the past 22 years, Soros’ agent network in Armenia has managed to:

- Take over the most of the media field,
- Privatize the civil society,
- Create mistrust and disunite the society,
- Discredit the state authorities, in particular the law enforcement systems,
- Compromise the traditional national institutions – family and the Church.

And as a result, seize the power in Armenia (see chapter 2).

Taking into consideration, that the activity of Soros all over the world is having negative consequences – financial crises, civil clashes, wars, territorial loss and terrorism, we offer to implement a large-scale coordinated fight against Soros’ agent network (see Chapter 1).

As in that perspective, as “*VETO*” social-political movement has registered positive results in just 3 months (see Chapter 3), with the current communiqué we offer to:

- Organize meetings and discussions among anti-Soros activists and unions in different countries,
- Specify the cooperation format,
- Do an exchange of experience and combination of effective methods of fight,
- Create an international body/center for the anti-Soros fight,

As a result of this, develop new effective technologies against the destructive activity of Soros through cooperation and joint efforts, taking into consideration the national and traditional features in each country.

The current communiqué is an initial document, with which “*VETO*” social-political movement is going to start negotiations with the healthy and concerned forces of the world around the agenda noted in the communiqué.
